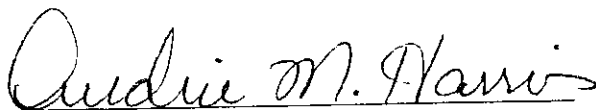
PETITIONER, THE TOWN OF PONCE INLET, FLORIDA'S,

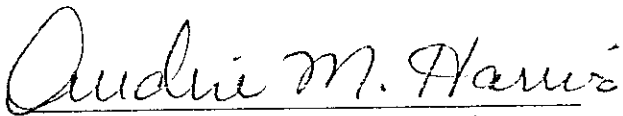

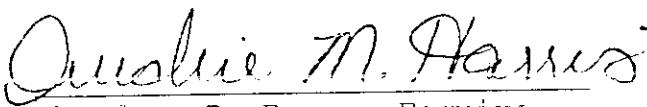
