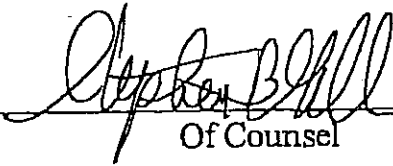
Pursuant to Florida Rule of Appellate Procedure Rule 9.320, Petitioner respectfully requests oral argument in the above-captioned matter and states:

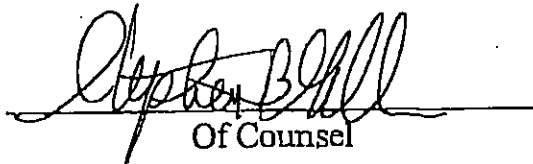
