not arrest me because there was no proof. I
was also accused of stealing the store buggy
and also there was no proof. All the 7 day
curable letters were made up lies, but I
fixed them and they had nothing to do

I was evicted supposedly for pushing
hitting or whatever maintenance said
about me was a lie I was the one
who call 911 on May 31st 2018
about his continued harrasing me

anger palatka housing so much MR Cleveland
Hobbs made up a lie about me. There is no
evidence that I did anything to him
again I was not arrested for anything
plus if had I did anything to MR Hobbs
why would he come back to my apt again
on that same day to evict me 911 they
staff they have He came back to continue
to bully me. to show me that he could do
to me what he wants to to me. my house
has never been inspected and I have never
been in any trouble for my apt being dirty
Because they never came to see about me
I begged them on many of times to please
help me with the Black mold, roaches but MR
Cleveland Hobbs would never come. They had
just renewed my lease so what does that
tell you. But after I complain they denied me
fun time with them I sent in pictures showing
I was Excluded from having any fun time
with palatka housing. They neighbors continued to
call me names along with MR Cleveland Hobbs
plus MR Hobbs threatening to shoot me, he said he
had a bullet for me I also sent in picture of
me being locked in my apt with the door tied up
and things push up against it to keep them from coming in

in to kill me I was so afraid
of these folks I gave up the keys
and walked away from my apt. These
people ignored Doctors orders, fema orders
this happen after the storm Irma hit
Palatka Florida so FEMA came and said
this was not caused by the storm Irma
it was External and that the housing Authority
needed to fix it I was in Michigan in Oct 2017
and when I return their was ^{black} mold in my
laundry room and when I ask for help
MR Cleveland Hobbs words were IF you clean
up you want have Black mold I never had
ever seen this man before in my life so why
was not able to get maintance instead I
was crutensize

and treated so unfair MS Tashis man's small.

MR Michael Rouel got my records from Ridgeway mental health center in Oakridge Tenn, showing palatka housing authority that I do have some learning disabilities only 9th grade education, I had a stroke the year before I moved into Auntie man spells apt, my income comes from SSA and SSI I have a problem with my head a lot of pain and muscle spasms and a pinch nerve in my head, neck, and lower back I have allergies real bad and I have given evidence from several doctors about me being allergic to mold it makes me sick and I was forced to live in it Because MR Cleveland Hobbs did very little to help me I was denied also to have chairs on my front porch I was told to get rid of them or else I would be kicked out I had things on my back porch and only when I told about the mold and roaches is when I was told to get rid of those things too, They call my stuff rubbish. I had a utility trailer an old trailer to help me to move things back n forth to help my church with the lawn mowers I had to get rid of also, we were helping the church with the 2 lawn mowers I had 2 bikes and a grill a Exercise bench which MR Cleveland tried to get us to sell to his friend and my husband said no, He was trying to say that we were selling things out of our apt, When my husband went to Jail one of the maintenance men bought my husband's drill for \$5.00 because I was hungry that was the only time. He was trying to set me up by sending his friends to my place to try and buy exercise bench as if we were a store. Felicia they help me with my application when I applied for housing I put

on the paper what she told me to put down
I told her that we both needed help
my husband only has an 8th grade education
we were just following orders. I sent in
pictures of things other folks had that I was
not allowed to have and 75 pages of other
documentation to show HUD Palatka housing and
Tallahassee Human Relations what was going on
I have some evidence my husband is a witness
They made him print over Roach droppings to cover
up hoping to keep me from being so sick. Because
Mr Cleveland said he could not do it, he did not
have the time to do he said it would take him
two weeks to paint I have been begging for my
apt to be painted since I moved in the walls were
dirty and patched up but never painted. Mr Cleveland
Haber said this on April 17, 2018 after he left holes
in my ceiling in 2017 of November He was upset
because I went to the health dept, Environmental health,
the news paper and to a whole lot of other people
including the police I call them twice I
have some 911 calls documentation where I
call twice on Palatka housing agents for
harassing me and retaliating against me all I
even ask was for maintenance help, but was talk
down to for asking so I want further to get
some help, at least I tried to but Palatka has
many friends who would lie for them
I was so afraid people in the apts were
threatening me that I needed to go. Because I was
not want there. Even Mrs Cooper from HUD
She even told me that I should just leave with
no where to go I lost every thing I had ➡
