**PETITIONER’S MOTION FOR CLARIFICATION REGARDING ORDER ON
RESPONDENT’S MOTION TO STRIKE**

School District of Manatee County, Florida (“Petitioner”), by and through the undersigned counsel, moves this Court and states:

1. On August 7, 2019, Lincoln Memorial Academy Inc. (“Respondent”), filed a Motion to Dismiss Petitioner’s Notice of Immediate Termination and Amended Notice of Immediate Termination with prejudice. (Dkt. 8).
2. On August 9, 2019, Respondent filed a Motion to Strike the Amended Notice of Immediate Termination. (Dkt. 14).
3. On August 9, 2019, this Court issued an order denying Respondent’s Motion to Strike the Amended Notice of Immediate Termination. This Court found that the issues of due process and proper notice of the charges constituting the grounds for immediate termination of Respondent’s charter will be adjudicated at the hearing scheduled to commence on August 26, 2019, along with the substantive allegations giving rise to the Notice of Immediate Termination. (Dkt. 15).
4. It is unclear whether this Court’s order served as a denial of Respondent’s Motion to Strike and Motion to Dismiss, therefore requiring no further briefing before the August 26, 2019

hearing, or whether this Court will address Respondent's Motion to Dismiss at the August 26, 2019 hearing, therefore requiring Petitioner to file an answer to the Motion to Dismiss by Thursday August 15, 2019.

WHEREFORE, Petitioner respectfully requests clarification on the status of Respondent's Motion to Dismiss.
