ORDER TO SHOW CAUSE

This matter came before the undersigned on Respondent's Motion for Summary Recommended Order (Motion), filed on March 17, 2022. The undersigned accepts the Motion as a motion to relinquish jurisdiction based on the assertion that the Petition for Relief is unrelated to the allegations raised in the Employment Complaint of Discrimination that would have been subject to investigation by the Florida Commission on Human Relations. Respondent also alleges that the allegations in the Petition for Relief are time-barred, or subject to the application of res judicata, also known as administrative finality. Such would leave no genuine issue as to any material fact pursuant to section 120.57(1)(h), Florida Statutes.

Pursuant to Florida Administrative Code Rule 28-106.204, "[w]hen time allows, the other parties may, within 7 days of service of a written motion, file a response in opposition." A review of the docket reveals that no response in opposition to the Motion has been filed.

Accordingly, it is

ORDERED that Petitioner shall show cause, in writing, by 5:00 p.m. on Thursday, March 31, 2022, why Respondent's Motion should not be granted.
