SUMMARY OF THE RULE: This emergency rule sets forth the provisions for the **Super Grouper Black Friday Promotion**.

53ER22-67 Super Grouper Black Friday Promotion.

(1) On November 25, 2022 a/k/a "Black Friday" (one day) ("Promotion Period"), the Florida Lottery will conduct the Super Grouper Black Friday Promotion ("Promotion").

(2) Number of Winners, Prizes, and Winner Selection/Announce Date.

*No cash substitution will be made. At the Lottery's discretion, a substitution of equal or greater value may be made.

(3) How to Enter.

(a) Players who purchase a \$10 GROUPER® Super Sampler ("Qualifying Purchase") on November 25, 2022 may enter the Promotion for a chance to win the prize described in subsection (2), above.

(b) Players making a Qualifying Purchase wanting to enter the Promotion shall provide a photograph of himself/herself holding his/her \$10 GROUPER Super Sampler ticket purchase to the Florida Lottery. Players shall ensure that all seven (7) tickets, or six (6) tickets and the coupon for the PICK 3 Str/Box PLUS FIREBALL ticket, if the ticket did not print, making up the GROUPER Super Sampler purchase clearly appear in the photograph. When photographing, tickets may be fanned out or overlap but must clearly show at least the top ticket, the language printed at the top of the ticket, and the date printed on the ticket. The player will not include any other individuals in the photograph. The player shall then email a single photograph to the Florida Lottery at promotions@flalottery.com; this constitutes an "entry." No other method of entry is permitted. Only one (1) entry per player is permitted, and only one (1) prize will be awarded per player. Fictitious names and business names will not be accepted and shall subject the player and any associated entry to disqualification. The Lottery must receive the emailed entry containing a photograph by 11:59:59 p.m. (ET) on November 25, 2022. Should the photograph submitted be indiscernible, at the Lottery's sole discretion, the entry may be disqualified, and no additional entry is permitted.

(c) Only Super Grouper purchases, subject to retailer and Lottery office hours, and associated entries made on November 25, 2022 by 11:59:59 p.m. are eligible.

(d) The odds of winning depend on the number of email entries received during the Promotion Period.

(e) Prizewinners will be selected using the nth entry selection process.

(4) How to Claim. The Lottery will notify prizewinners on or about November 28, 2022 via the email address used by players to enter the Promotion. Aside from issuing an email, no other attempt will be made to reach a prizewinner. Within five (5) business days of the Lottery's issuance of an email to a prizewinner, the prizewinner must reply and provide proof of identification and age, along with a valid Florida mailing address where delivery of the prize is to be accomplished. If the Lottery does not have contact with a prizewinner within five (5) business days, the prizewinner shall waive the right to receive his/her prize.

(a) Mailing by U. S. Mail. Mailing of the prize (1 book of Game Number 1472, "National Lampoon's Christmas Vacation") must be made to a valid Florida address. The Lottery will not be responsible or liable for lost, misdirected, stolen, or

otherwise failed mailings, and any prize not received will not be replaced or compensated in any manner. A signature will be required upon delivery.

(b) Acceptable forms of identification are set forth in the Lottery's rule on the Payment of Prizes, 53ER22-54, F. A. C. A copy of the Lottery's Payment of Prizes rule can be obtained by contacting the Florida Lottery, Office of General Counsel, 250 Marriott Drive, Tallahassee, Florida 32301. The name on the identification must match the name provided to the Lottery at the time the prizewinner entered the Promotion.

(c) If a prize cannot be awarded for any reason, the prize will not be awarded.

(5) Taxes. All Federal, state, and/or local taxes and/or other costs and fees on all prizes will be the responsibility of the prizewinner.

(6) Other Restrictions and Provisions.

(a) A prizewinner must be at least 18 years of age.

(b) All prizes are subject to the provisions of chapter 24, F.S., and rules promulgated thereunder. Prizes will be paid in accordance with the Florida Lottery's rule governing payment of prizes. FINAL ORDER

APPROVING CITY OF KEY WEST ORDINANCE NO. 22-24

The Department of Economic Opportunity ("Department") hereby issues its Final Order, pursuant to Section 380.05(6), Florida Statutes, approving land development regulations adopted by the City of Key West, Florida ("City"), by Ordinance No. 22-24 ("Ordinance").

FINDINGS OF FACT

1. Section 380.0552, Florida Statutes, and Rule 28-36.002, Florida Administrative Code, designate the City as an area of critical state concern.
2. The City adopted the Ordinance on August 16, 2022, and rendered it to the Department on September 20, 2022.
3. The Ordinance revises Chapter 108, and Article XII, of the City of Key West Land Development Regulations to provide 150 affordable early evacuation pool units for two properties in the City, one located at 241 Trumbo Road and another at 240 Trumbo Road.

CONCLUSIONS OF LAW

4. The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. See Section 380.05(6), Florida Statutes.
5. "Land development regulations" include local zoning, subdivision, building, and other regulations controlling the development of land. Section 380.031(8), Florida Statutes. The regulations adopted by the Ordinance are land development regulations.
6. The Ordinance is consistent with the City's Comprehensive Plan generally, as required by Section 163.3177(1), Florida Statutes, and is specifically consistent with Objective 1-1.16, Policy 1-1.16.1, and Policy 1-1.16.2.
7. All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the principles for guiding development for that area. See Section 380.05(6), Florida Statutes. The Principles for Guiding Development for the City are set forth in Rule 28-36.003, Florida Administrative Code.

8. The Ordinance is consistent with the Principles for Guiding Development for the City as a whole, and specifically furthers the following Principles:

(1)(a) Strengthen local government capabilities for managing land use and development; and

(1)(h) Protection of the public health, safety, welfare and economy of the City of Key West, and the maintenance of Key West as a unique Florida resource.

WHEREFORE, IT IS ORDERED that the Department finds that Ordinance No. 22-24 is consistent with the City's Comprehensive Plan and the Principles for Guiding Development for the City and is hereby APPROVED.

This Final Order becomes final 21 days after its publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights below. DONE AND ORDERED in Tallahassee, Florida.

FINAL ORDER

APPROVING MONROE COUNTY ORDINANCE NO. 016-2022

The Department of Economic Opportunity ("Department") hereby issues its Final Order, pursuant to sections 380.05(6) and 380.0552(9), Florida Statutes, approving land development regulations adopted by Monroe County, Florida, Ordinance No. 016-2022 (the "Ordinance").

FINDINGS OF FACT

1. The Florida Keys Area is designated by Section 380.0552, Florida Statutes, as an area of critical state concern. Monroe County is a local government within the Florida Keys Area.

2. The Ordinance was adopted by Monroe County on August 17, 2022, and rendered to the Department on September 19, 2022.

3. The Ordinance amends the Monroe County Land Development Code ("Code") to create Section 130-140 which establishes the Safe Harbor Community Center Overlay District ("SHCC"). The Ordinance further establishes the purpose and intent, permitted uses, density and intensity, off-street parking

and signage requirement, required setbacks, and the boundary of the overlay district.

CONCLUSIONS OF LAW

4. The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. See §§ 380.05(6) and 380.0552(9), Fla Stat.

5. “Land development regulations” include local zoning, subdivision, building, and other regulations controlling the development of land. § 380.031(8), Fla. Stat. The regulations adopted by the Ordinance are land development regulations.

6. The Ordinance is consistent with the Monroe County Comprehensive Plan generally, as required by Section 163.3177(1), Florida Statutes, and specifically, with Goal 101 and Objective 101.5.

7. All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the principles for guiding development for that area. §§ 380.05(6) and 380.0552(9), Fla Stat. The Principles for Guiding Development for the Florida Keys Area of Critical State Concern are set forth in Section 380.0552(7), Florida Statutes.

8. The Ordinance is consistent with the Principles for Guiding Development as a whole, and specifically complies with the following:

(a) Strengthening local government capabilities for managing land use and development so that local government is able to achieve these objectives without continuing the area of critical state concern designation.

(f) Enhancing natural scenic resources, promoting the aesthetic benefits of the natural environment, and ensuring that development is compatible with the unique historic character of the Florida Keys.

(g) Protecting the historical heritage of the Florida Keys.

(n) Protecting the public health, safety, and welfare of the citizens of the Florida Keys and maintaining the Florida Keys as a unique Florida resource.

WHEREFORE, IT IS ORDERED that the Department finds that Monroe County Ordinance No. 016-2022 is consistent with the Monroe County Comprehensive Plan and Principles for Guiding Development for the Florida Keys Area of Critical State Concern and is hereby APPROVED.

This Order becomes effective 21 days after publication in the Florida Administrative Register, unless a petition is timely filed as described in the Notice of Administrative Rights below.
