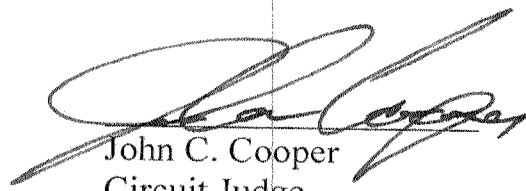
FINAL JUDGMENT
