**REQUEST BY FLORIDA HOUSE OF REPRESENTATIVES  
TO PARTICIPATE IN ORAL ARGUMENT**

Pursuant to Florida Rule of Appellate Procedure 9.320 and this Court's March 29, 2019, scheduling order, the Florida House of Representatives requests to participate in oral argument scheduled in this case for August 28, 2019.

Given the number of interested parties that have requested to participate, the House also requests that the Court enlarge the time allowed for argument, if the Court is inclined to grant one or more of these requests.

As a joint possessor of the entirety of the State's legislative power, the House is well-suited to address the Court's questions regarding whether an amendatory effort like the one now before the Court—which purports to add new policy to the Constitution—violates the limited initiative power reserved in Article XI, section 3.
