REQUEST FOR ORAL ARGUMENT

Appellant/Petitioner, BILLY JIM SHEPPARD, JR., requests oral argument in this case pursuant to Fla. R. App. P. 9.320. Billy Jim Sheppard, Jr., has been sentenced to death.
