
STIPULATION OF SETTLEMENT

THE PARTIES STIPULATE THAT:

Petitioner, and Respondents by their authorized counsel have come to terms concerning Petitioner's challenge of the Florida Commission on Human Relations' determination of no reasonable cause, and have agreed to the following: Petitioner and Respondent will sign a mutual general release entitled "Settlement Agreement and Release" which states, in part, that Respondent, Gerald (Mick) Vorbeck, will purchase Petitioner's Mobile Home for the sum of \$5,000.00; and that Petitioner will vacate Tropic Isles Mobile Home Park and shall not enter Tropic Isles Mobile Home Park or any other property known by Petitioner to be owned or operated by Mr. Vorbeck at any time or for any purpose.

The parties request that the Honorable Arnold H. Pollack, Administrative Law Judge, accept the parties' stipulation of settlement and execute an order concluding Petitioner's challenge of the Florida Commission on Human Relations' determination of no reasonable cause.
