

This matter came before the Court upon motion by the Parties and the Court being fully advised in the premises, it is hereby:


ORDERED that:

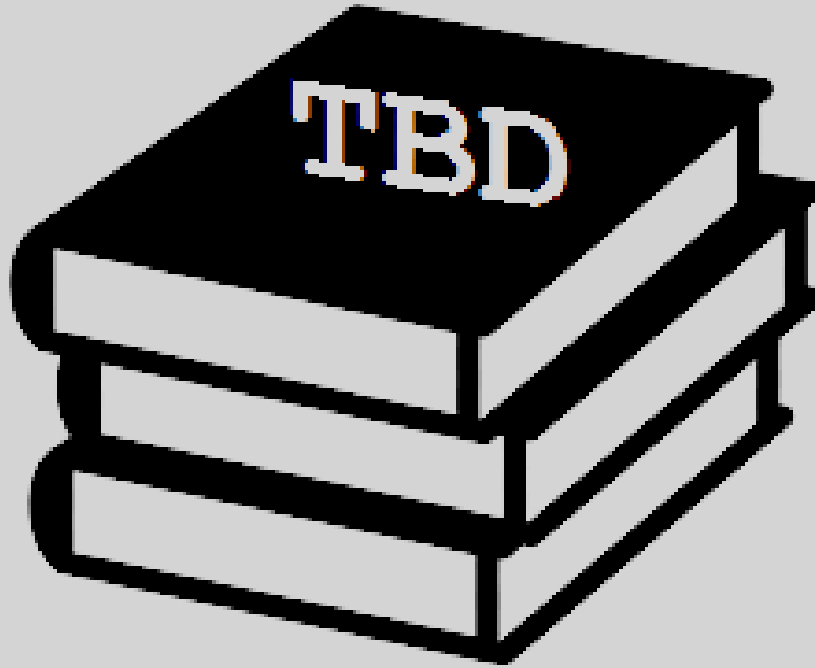
