PLAINTIFF'S COMPLAINT**



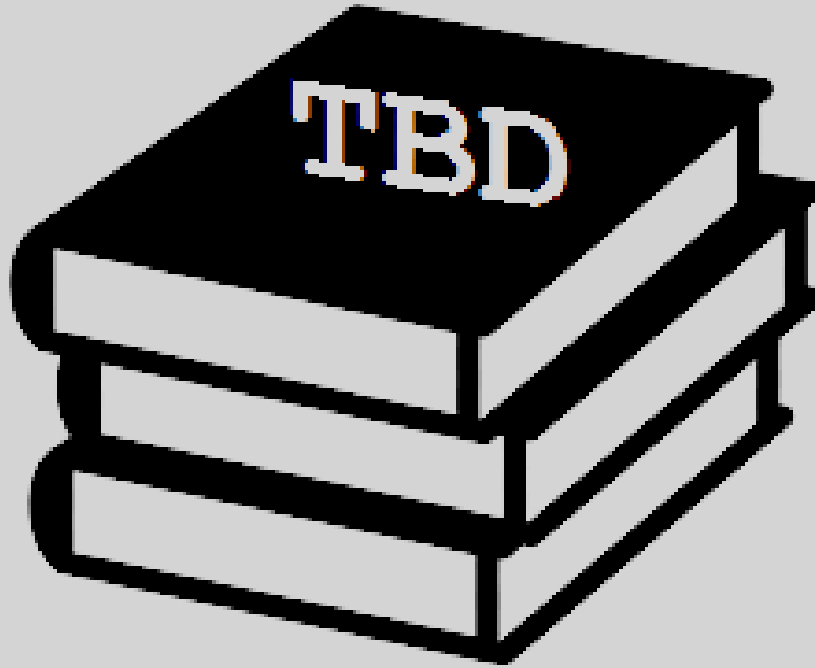
