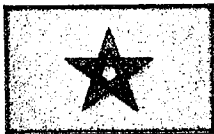

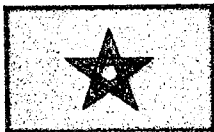

On or about the Third Day of the Fourth Month Fourteen Thirty Seven (1437) [Gregorian Calendar Year (G.C.Y.) 2017 – April 3], declarant did file Private Civil Action Fourth Judicial Circuit Case Number 16-2017-2142. On or about the Third Day of the Fourth Month Fourteen Thirty Seven (1437) [G.C.Y. 2017 – April 3], declarant did serve Private Civil Action Fourth Judicial Circuit Case Number 16-2017-CA-2142 upon respondent(s). The respondent(s) did have the reasonable time period of twenty (20) days to answer, respond, and bring forward documentary evidence with law and great specificity in rebuttal to any facts stated in declarant's Private Civil Action Fourth Judicial Circuit Case Number 16-2017-CA-2142. Said answer or response must be verified and signed in hand-writing in blue wet-ink under respondent(s) full liability under the penalty of perjury.

6. On or about the Twenty-Fourth Day of the Fourth Month Fourteen Thirty Seven (1437) [G.C.Y. 2017 – April 24], the reasonable time period of twenty (20) days did expire with no record of respondent(s)' answer or response. Entry of Default is not a final judgment, and may not be appealed. (see *Enron Oil Corp. v. Masonori Diakohara*, 10 F. 3d. 90, 95 (2d. Cir. 1993)). Preclusion (**Res Judicata and Collateral Estoppel**) occurs at the time of a Default Judgment. (see *Morris v. Jones*, 329 U.S. 545, 552, 67 S.Ct. 451, 91 L.Ed. 488 (1947)). Entry of Default severely limits defaulting party's subsequent participation in the action as the defaulting party is no longer entitled to participate in the determination of its liability in the action (see *Dow Chem. Pac. Ltd. V. Racator Maritime S.A.*, 782 F.2d. 329, 336 (2d. Cir.1986)). In fact, the case may proceed to [summary] judgment with no notice or limited notice to the defaulting party. The defaulting party has no standing to challenge the factual allegations of the [documentary evidence] to which they or it defaulted. (see *Taylor v. City of Baldwin*, 859 F.2d. 1330, 1333 n.7 (8th Cir. 1998)).
